
## **QUALIFICATIONS AND TRAINING STANDARDS**

In order to exercise the powers of a law enforcement officer, Marquette University police officers must:

- (A) Meet the requirements of section 165.85(4)(a)2 and (7)(a), Wis.Stats, as a law enforcement officer;
- (B) Agree to accept the duties of a police officer under the laws of the State of Wisconsin in a manner prescribed by the President of Marquette University;
- (C) Meet further reasonable qualifications for employment deemed necessary by the Chief of Police, Marquette University;
